



# Knowledge Transfer under the Belt and Road Initiative

## Background

The Belt and Road initiative, proposed by China, provides a visionary blueprint for global economic development in the new world order. Taking reference from the historic Silk Road, which transformed the nature of international trade links in ancient times, the Belt and Road Initiative offers a modern-day solution that fosters inclusive growth and development in the 21st century.

The Belt and Road refers to the land-based "Silk Road Economic Belt" and the seagoing "21st Century Maritime Silk Road". The routes cover more than 60 countries and regions from Asia to Europe via Southeast Asia, South Asia, Central Asia, West Asia and the Middle East, with a population of around 4.4 billion (63% of world population)<sup>1</sup>, currently accounting for some 30 per cent of global GDP and more than 35 per cent of the world's merchandise trade. By 2050, the Belt and Road region aims to contribute 80 per cent of global GDP growth, and advance three billion more people into the middle class.<sup>2</sup>

Pioneering with talent exchange and collaborative education, Chinese universities have been actively engaging their counterparts among the Belt and Road countries. However, collaborations in knowledge transfer to serve the local communities and regional economies have yet to be explored.

#### The Forum

In this context, we have set the theme of this ISTA KT Management Forum as "Knowledge Transfer in the Belt and Road Initiative", to be held in conjunction with the 22nd Annual General Meeting of International Strategic Technology Alliance on 7 December 2017. University administrators and experts from the Belt and Road countries are invited to this mini forum to share their views on the opportunities arising from the Belt and Road Initiative as well as to interact with ISTA members to explore possible collaborative actions.

Participants of this half-day Forum will include representatives from institutional ISTA members, typically top executives overseeing R&D and knowledge/technology transfer of their respective universities, senior university directorates responsible for commercialization, and public administration officers and intermediaries who are actively involved in university-industry technology transfer.
